NOTE: Security deposit will be refunded after event, providing all property has been returned to its Original condition as to cleanliness and order, also any supplies used must be replaced

Security deposit will be forfeited if cancelled within 30 days of Rental Date. Fee will be returned after event. If not cancelled.

Lessee will occupy premises ONLY as:

Lessor is a private, not public, entity. As such Lessor reserves right to accept or exclude rental to individuals, groups or organizations. Lessor cannot rent to Motorcycle Clubs with exception of current contracts as defined in Bylaws.

Lessee will pay a fee of \$ 35.00 for any payment that is returned by any financial institution for any reason. Any late charges will continue to apply until a valid payment is received. Lessor will accept the following methods of payment:

Cash: Money order: Personal check; Other

Lessor may deduct for cleanup or repair costs due to damage.

Remaining Security Deposit will be returned to Lessee within 10 days after lease termination.

Lessee will:

- I. Keep the property clean and safe
- II. REMOVE all trash, garbage and any other waste materials as required by Landlord and the law from within the hall, clubhouse and pavilion. With prior approval dumpster may be available.
- III. USE CARE WHEN USING ANY OF THE ELECTRICAL, PLUMBING, HEATING, VENTILATION OR OTHER FACILITIES OR APPLIANCES ON THE PROPERTY

Lessee will not:

- I. Keep any flammable, hazardous and/or explosive materials on the property
- II. Destroy, damage or deface any part of the property
- III. Remove any furniture or equipment from the Clubhouse to use outside

Lessee is responsible for all guest obeying the Rules and Regulations and all laws.

A charge of \$250 will be applied for cleaning the premises if not broom clean.

The "Security Deposit" shall be held by Lessor as security for the Performance of all the terms, covenants and conditions of this lease and for the cost of any trash removal, housekeeping and the cost of repairs and/or the correction of damage (which is in the opinion of the Lessor, in excess of normal wear and tear), otherwise the "Security Deposit" or any balance thereof, shall be returned after the Lessee has vacated and left the premises in an acceptable condition following a personal inspection by the Lessor. If the Lessor determines that any loss, damage or injury is chargeable to the Lessee, hereunder, exceeds the "Security Deposit", the Lessor at his option may retain the said sum as liquidated damages or may apply the sum against any actual loss, damage or injury and the balance thereof, will be the responsibility of the Lessee. Lessor's determination of the amount, if any, to be returned to the Lessee shall be final.

The Lessor may furnish additional services not herein provided for but any such service shall be gratuitous unless otherwise agreed and shall not be an obligation of the Lessee or part of the consideration for the rent.

THE CLUB GAS GRILL IS NOT AVAILABLE FOR USE

Any supplies used must be replaced, i.e. Food, Fuel, Serving Dishes/Utensils, Beverages and Paper Stock.

Lessee will indemnify and save Lessor harmless from any and all loss by Lessee's breach of any of the covenants, terms and conditions of this lease or caused by his family, guests, visitors and employees.

Lessor shall not be liable for any damage, compensation or claim by reason of inconvenience.

Lessee may not transfer this lease or sublease (rent to another person or group).

Lessee shall not provide or allow to be provided alcohol or alcoholic beverages on the premises at any time to any individual under the age of 21 years old.

Lessee shall be responsible for the provision of alcohol on the premises and shall monitor the use of alcohol on the premises including monitoring the age of those consuming alcohol on the premises, the condition of guests consuming on the premises and providing appropriate transportation to any guest who consumes alcohol on the premises and becomes visibly intoxicated. Lessee is responsible to keep property free of any illegal intoxicating agents.

Lessee hereby released Lessor from any and all liability from the service of alcohol on the premises and hereby agrees to indemnify and hold harmless Lessor for any and all damages, attorney's fees and costs relating to defending any and all lawsuits and/or claims made as a result of the service of alcohol to any guest on the premises.

Lessor undertakes no direct legal or financial responsibility for the safety of the Lessee or the guests of the Lessee.

Lessee assumes all risks and liability arising out of any activity that occurs during the rental of the premises.

Lessee hereby forever releases Lessor and all related participants from any and all claims and causes of action that Lessee or Lessee's guests or their representatives now have or may have in the future for personal injury, property damage or wrongful death arising out of the activities that take place on the premises pursuant to this lease.

Lessee shall be 100% liable for any and all personal injury, property damage or wrongful death as well as any and all medical expenses incurred as a result of any injury or property damage arising out of the activities on the premises that is the subject of this Agreement.

By signing this Agreement, Lessee agrees to release, indemnify and hold harmless Lessors as well as all of their employees, agents, representatives, successors, directors and members from all losses, claims, theft, demands, liabilities, personal injuries, wrongful death, causes of action or expenses, known or unknown, arising out of the use of the premises and/or the activities taking place during the use of the premises pursuant to the use of this Agreement.

Lessor is not responsible for any damage to person or property caused by the use of the premises or the activities therein that are the subject of this Agreement.

INDEMNITY

In addition, Lessee agrees to indemnify and hold harmless the Lessor, its officers, staff, members and agents working on behalf, from any and all claims, actions, suits, costs, damages and liabilities resulting from the breach of this Agreement, the negligent actions, willful misconduct or omissions of Lessee and Lessor's guests, invitees, agents and subcontractors.

ALCOHOL CONTROL

The Lessee is ultimately responsible for the safety of all its invitees, guests, agents or subcontractors, including the distribution and consumption of alcohol.

Lessee's guests that appear to be thirty (30) years of age or under shall be carded by the bartending service, therefore they must either have a valid driver's license or valid picture ID.
